Elder nominations - 2020



Our church members were recently asked to put forward names of potential elders for Kenmore Church. Our aim has been to stagger the appointment of elders so that as various people rotate on and off the board, there is a good degree of continuity and experience retained.

The process of appointment is:

- 1. Members are asked to nominate potentially suitable elders.
- 2. Names are submitted to the existing board who then prayerfully undertake an interview and review process to ascertain the most suitable candidates based on factors including: experience, skill set, and representation of our church demographic. All potential elders are required to adhere to and support our constitution, statement of faith, and relevant guidelines for churches provided by Churches of Christ Qld.
- 3. Elders submit their recommended names to the membership at a special members meeting for appointment.

The role and qualifications of elder at Kenmore Church

Biblically, Elders are shepherds who oversee the Church. As shepherds¹, their leadership role includes feeding the Church spiritually²; ensuring the people are cared for, especially the sick³; guiding the Church in godly directions as outlined in the Bible⁴; guarding the Church from dangers⁵; and watching⁶ over the Church to be aware of their spiritual health and potential risks. Elders are also overseers⁷ who watch over four groups⁸: themselves as individuals, the Elders together as a group⁹, the leaders who report to them¹⁰, and the Church as a whole¹¹. Their overall purpose is to lead believers to participate in the mission of God.
